The Merchant Shipping Directorate of the Authority for Transport in Malta (Transport Malta) has been made aware of STCW training certificates issued under Chapters V and VI of the STCW Convention, as amended by a training centre purporting to be approved by Transport Malta.

The certificates issued by Anchor Maritime Training Center Inc. which were received for verification by this Directorate have been issued for the following courses:

- Crowd Management, Passenger Safety and Safety Training for Personnel Providing Direct Services to Passengers to Passengers in Passenger Space (sic.)
- Proficiency Crisis Management and Human Behaviour Training Including Passenger Safety, Cargo Safety and Hull Integrity Training (sic.)
- Basic Safety Maritime Training Course (sic.)
- Security Awareness Training for all Seafarers (sic.)

Transport Malta considers such certificates as being fraudulently issued and Parties are not to accept any of the certificates attached to this communication as an annex.


This Directorate cannot confirm whether there are more certificates or variants purporting to be issued by the above mentioned Anchor Maritime Center Inc.




